First Vice-President, Helen D. Townsen, called to the chair.

Report of President P. E O. Sisterhood, Miss Margaret Durward:

PRESIDENT'S REPORT.

My dear Sisters in P. E. O: This report is of necessity a very brief one. After asking all other officers to make their reports as short as possible, it would be out of place for me to give a full recital of all that has been done during the past two years. Needless to say that when one assumes the duties of Supreme President at a time when a great world war is upon us, and when disease and pestilence worse than any in our history is spreading its black wing over us, one has undertaken a new and untried responsibility and no end of work. The unexpected is always the thing to expect.

The sudden death of Mrs. Effie Hoffman Rogers early in 1918, which saddened us all, caused me to edit the March issue of the Record in order to get it out as per contract. The appointment of Mrs. Winona Reeves as Editor has given the greatest satisfaction from all quarters so far as I can determine.

he establishment of a regular monthly board letter sent out the first of every month, and the return letter from each member smetime during the month has kept us all in touch with each others work. So far as possible all bills have been paid promptly at the first of every month.

Much of the correspondence has been directed toward two great efforts, each a seeming contradiction to the other; during the winter and spring of 1918 an effort to show many states and many local chapters that we must continue our meetings and state gatherings even tho we were in the midst of war, and thus be prepared to serve our country to the utmost since we were organized and trained for that purpose; the next few months after that when the ban had been placed for months on all meetings and a great distress had arisen in many quarters because meetings could not be held and no progress made, I found myself writing much that sounded contradictory to my earlier statements; my main theme became -"Hold the line just where we are. We are large enough and strong enough to overcome temporary lapse." We shall hear in a later report how splendidly we have given an account of ourselves as "Patriots Every One," and we shall hear how wonderfull we rallied after the epidemic was over and made good all the time lost.

The special duties growing out of the last Convention in Omaha were these:-

a-A Liberty Bond for every Chapter.

b-100,000 in the Educational Fund by 1919.

c—Preparing a new history of P. E. O. d—A complete revision of the Constitution.

These four duties have engaged much of my time and the later reports will show what has been accomplished.

I met the Revision Committee three times, once in Chicago during last Christmas week at the home of Mrs. Parks, once with Miss Johnson at Lincoln, Nebraska, last June and last week in my home at Ft.

Last year I visited all Conventions east of Colorado, eleven in number, and this year all the State Conventions west of Colorado, taking time enroute with no added expense to visit the subordinate chapters at Rawlins and Laramie, Wyoming; Salt Lake City, Utah; Reno, Nevada; and the three chapters in British Columbia.

Our finances have given me much thought with prices soaring everywhere, paper so much higher that it costs about twice as much to publish the Record as formerly; with railroad travel nearly doubled and postage one-half more than formerly and with a rather depleted treasury to begin with, it has taken a tremendous effort to do the work bfore us and yet keep our heads above water; but by much planning and consulting of routes and times of travel your organizer and myself are happy to say we have covered all our territory and have no greater bills than usual.

You have had an excellent executive board to work with the President; each in her own place has attended faithfully to her duties, has been capable and efficient. One could wish for none better.

It has been a wonderful privilege to serve during these two hard, happy, trying years; to live with you and work with you when the days were dark with foreboding, and dreary with sorrow; to be able to emerge from the shadows and come out into the sunlight of a day, bright with fulfillment and radiant with promise; to be thankful with you that the war is ended and that we give ourselves to the task of reconstruction; that P. E. O. has justified itself on this its anniversary day. For all your help and good will I am deeply grateful.

Report of Organizer, Mrs. Alice Scott. October 15, 1919. Number of subordinate chapters, 52.

August 1, 1919. Number of subordinate chapters, 59.

Organized in two years, seven chapters. Inspected in two years, fifty chapters.

Miss Durward inspected four chapters. Mrs. De Money organized one of the seven. Your Organizer inspected forty-six, and organized six chapters. Inspected one chapter that I had organized the first year, making fifty-one chapters visited by me. This leaves four chapters not inspected. We have written during the two years thirteen hundred seventy-three letters and have spent in actual service away from home one hundred and five days.

Organization and inspection expense, \$684.25, the average for each chapter \$11.24. Office expense, \$61.13—\$38.67 for stamps, —\$22.46 for telegrams, express on supplies, special delivery stamps, registered letters and supplies.

We organized two chapters in Michigan, making it possible for Michigan to have a State Chapter, which they are planning to do in October. No chapters disbanded during the year and comparatively few members have been rquired to the inactive list.

Our subordinate chapters are in fifteen

states, the District of Columbia, and British Columbia. Generally speaking, the chapters are in splendid condition, interested and enthusiastic for the progress of the Sisterhood. We regret that four subordinate chapters had to be neglected and that we have no state charter to present to you.

We have been disappointed many times in the last two yars and our report seems very small but it represents many hours of labor, many Pullman nights and weary days of travel and homesick hours. On the other hand, it represents many pleasant associations, delightful chapter meetings, bouquets galore, souvenir spoons and corsage bouquets, wonderful drives through the show places of our country, and friendships formed that will make all my succeeding days richer and better for this experience.

Report of Custodian of Supplies, Mrs. Nancy A. Olds:

In accordance with the request of our President I will just give a summary report of the work. The total receipts of the office for the term are \$4,051.96; Disbursements, \$4,075.51; cash on hand, \$278.-71.

I have filled 2,155 orders, packed 71 boxes of supplies for new chapters, written 1,500 letters and many cards besides the extra multigraph work necessary to keep up the supplies.

for which this office receives no revenue.

The invoice of supplies shows a stock value of \$997.14, supplies on hand.

No words or figures can give a clear picture of the work of this office this term owing to the conditions in transportation as well as trade.

We have for the first time in five years sent out incomplete boxes for organization but up to date all chapters have received the supplies lacking at organization.

We wish to thank the officers and particularly the organizers for their patience and courtesy during the term.

The Auditor's report has been placed in the hands of the committee.

Her storehouse is full. Be true and faithful to your vows and the abundance of these good things will come to you.

Miss Durward instructed the corresponding secretary to reply to these greetings. Summary report of War Work, Mrs. Helen D. Townsend.

In offering you this report of the war work done by the Sisterhood, I regret to say that the record is far from complete. In some instances I have had no report from chapters but in many more cases I have had incomplete reports with the words "impossible to estimate," opposite some items. Or perhaps where the statement of an amount of money was required the words "gave generously" were substituted. The record of the work of the year 1917-1918 is much more complete than for the year 1918-1919. Though the war work did not end with the armistice there was, as you all know, a laxity in keeping the record of work done. I received some reports too late to be included in this report as you have it in your hands, but their figures will be added in the report as given in the minutes.

From the figures here given we deduce that we are a prosperous and pariotic organization.

You will notice that as an organization and as individuals we have invested over four million dollars in bonds and War Savings Stamps. Not all the chapters have bought bonds, and I was unable to learn exactly how many chapters have bought bonds.

You will notice that our gifts in money are almost \$230,000.00. About one and onehalf million hours have been reported as spent in war work, which would be 200,000 days of eight hours. If 100 women had done all the work it would have taken 2,000 days-or twenty years. You can figure out such interesting items for yourselves from the reports as given you. We congratulate the Sisterhood that its members have shown themselves such loyal citizens as even this incomplete report shows.

Many chapters located near cantonments have given entertainments for the men in service. One state had a committee to secure funds for such at a camp within its borders, and \$658,00 was collected and disbursed in the name of P. E. O. by chapters nearest the camp.

Many P. E. O.s took the course in first aid and many volunteered for service during the influenza epidemic.

One chapter has provided meals for 125 soldiers one day each week since 1916.

One chapter installed and is maintaining a P. E. O. bed in a military hospital.

In one state three-fourths of the P. E. O.s qualified for Red Cross recognization.

About half the chapters bought bonds as chapters.

Amount reported as invested in Liberty Bonds and W. S. S. by chapters and members \$4,572,165.00.

Money given to Red Cross, Y M. C. A., Y. W. C. A., Knights of Columbus, Belgian Relief, Salvation Army, Navy League, Council of Defense, War Camp Community Service, etc., \$397,520.00.

This report is very far from a complete record of the work done by this Sisterhood, as many chapters have kept no record and from some chapters I have had no report.

Moved by Mrs. Campbell, Colorado, and seconded this report be accepted. Motion carried.

Report of Editor of the Record, Mrs. Winona E. Reeves:

To the officers and members of the Twenty-fourth Biennial Convention of the Supreme Chapter of the P. E. O. Sisterhood, the Editor of the P. E. O. Record begs leave to submit the following report:

By appointment of the President of Supreme Chapter, we became Editor of the P. E. O. Record February 19, 1918, and began active work on March I, following. The first magazine edited by us was in April, 1918, issue, which very properly was made a memorial to the former editor, Mrs. Effic Hoffman Rogers, whose passing brought deep sorrow to many P. E. O.s.

We have edited, including the October number just off the press, nineten issues of the magazine.

The work of the office divides itself into two parts, the editing of the magazine and the care of the mailing list. There is work done on the Record every day of the month, —it is a full month's task.

To edit the magazine; to map out what it shall contain, to edit the material, to write the editorials and the original matter, to read the galley proof and again the page proof, constitutes the actual work on the magazine itself. That is the work done by the Editor which all of the Sisterhood see.

The part of the work of the office which you do not see is by far the more difficult; that is the care of the mailing list. This part of the work is of greatest importance for two reasons; first, it is through proper care of that list that members receive their magazines; and secondly, it is important because if it is allowed to become padded with

duplicate names, inactives or incorrectly written names it becomes a source of unnecessary expense to Supremt Chapter.

At the convention in Omaha, Mrs. Drake, in her president's report, called the attention of the convention to the fact that there was an error in the mailing list of about 2,000 names. It is a very easy matter for the President of Supreme Chapter and the trustees to discover an appreciable error in the mailing list because, as you know, it should be the same figure as the Supreme Corresponding Secretary's active list, plus twenty-five extra Records sent the Editor monthly to supply requests for extra copies. We have taken off of that list errors to the number of 2,254. When on August 20, 1919, we last compared the number on the mailing list with Mrs. Lela Weber's active list there was a difference of thirteen names on the two lists.

The removal of this error on the mailing list has saved Supreme Chapter \$67.62 every month which is \$7.62 more than the monthly salary paid the editor. These figures are on record with the Supreme President, the chairman of the Record trustees and with the Supreme treasurer, for these three officers have to do with the paying of the publisher's bill every month and therefore know the number of magzines published monthly.

The work of keeping a list of 21,500 names (in round numbers) is a task the magnitude of which you could not know until you had done it. The contract requires that the publisher shall send the editor the mailing list on the 12th of the month and it must be returned to him at the end of ten days. Some months it is a physical impossibility for one person to make the corrections in ten days, to put on the changes in address, the changes in names, initiations, dimits, reinstatements and deaths. We have put in twelve hours of time on nearly every day in March, April, and May, to correct the list, these being the three heaviest months.

As you know, during the biennial just closing, the corrections and changes have been sent to the state corresponding secreary and by her to the editor. One reason for the adoption of that plan at the Omaha convention, was that the state or Supreme

corresponding secretary, only have the correct active membership list for the states and subordinate chapters, and they know what members are eligible to receive the Out of our experience, we are Record. most anxious that the law shall be changed and that the local corresponding secretaries make their report of changes to be made on the mailing list, direct to the editor. This is the natural direct way for notifying the editor and involves one less person in the transaction; it saves postage and saves time. There should, however, be in the Record office a correct list of the active members that we may have a standard by which to check the mailing list. We therefore recommend:

First, that reports of all changes to be made in the mailing list be sent direct to the editor of the Record and that all names and addresses, if possible, be typewritten.

We also recommend that all Chapters be required to furnish the Record a copy of their active membership list annually on March 1st.

For the magazine itself we have great ambition. We wish so much that the form might be changed, that it were just the size of the cover plate and that the number of its pages might be increased to make it more like a magazine and less like a pamphlet or weekly periodical. The magazine should have a heavier cover which would give it a better style.

We appreciate all the difficulties under which the trustees have worked in their effort to publish the Record during a period of a fluctuating paper market with prices the highest known in years. We would by no means wish to add to their troubles, but do you feel that the form of the Record quite does our Sisterhood credit? The cost of a single copy of the Record is a little more than three cents or thirty-six cents a year which is not a very large amount for a Sisterhood such as ours. We are not offering any recommendation on a change of form in this report but we earnestly hope that the matter will come up for discussion in this convention.

As to the contents of the Record the increased number of State Chapters is going to make it necessary to cut the convention reports shorter next year than has been the custom in former years. The conven-

tion reports should not be strung out over so many months as they have in the past but should be printed while they are news, not after the minutes have been printed and distributed. The delay in the publication of convention reports has been due to two causes; lack of space but more often because the convention reporter did not send her manuscript in promptly.

With about 800 chapters and the numbers increasing every month, you see that the chapter letters are becoming a problem. The plan has been suggested that every month we give the digest of the letters which would make it possible to print the news from the letters almost as soon as it came to us. By a digest of the letters we mean this: that under the head of Kansas, for example, we would print the news contained in all the chapter letters we had received that month from chapters in Kansas. If that plan were followed journalists could send news items every month and not be limited to one letter annually. To read of a P. E. O. party or a B. I. L. dinner a year after it has happened isn't very thrilling news. Often a P. E. O. will have been dead for months before it is possible for lack of space to print the letter containing the news.

During the months in which we have served you as Editor we have had two ambitions, to get the Record to everyone who was entitled to it and second to make it such a publication as would make of the members who read it better P. E. O.s and which would place the Sisterhood in a good light before anyone outside its membership who by chance might read its pages. During the convention season of 1918 it was our great privilege through invitation of the various state executive boards to attend the Illinois, Iowa, Missouri and Nebraska conventions.

In 1919 upon the same invitation we attended the Iowa, Nebraska, Oklahoma, Kansas, Illinois, North Dakota and South Dakota conventions. The attendance at the conventions was of inestimable value to us, and of the greatest pleasure and inspiration.

In accordance with the law requiring it we have visited the publisher's office each year to talk over matters relative to the work. The cost to Supreme Chapter of these two visits was less than five dollars, because the visits were made when we passed through Kansas City enroute to other points and only the living expense while there was incurred.

Very early in our term, in May, 1918, we had the pleasure of a visit from Miss Durward and Mrs. Miller, chairman of the Record Trustees, who examined the mailing list, the filing cabinet and other records and discussed with us the work and policy of the magazine.

To the Record trustees I wish publicaly to express my gratitude for their kindness and consideration at all times. Mrs. Miller as Chairman has been of greatest assistance to us and our work together has been without a shadow of misunderstanding. The publishers have been fair and business like in all of their transactions.

I wish to speak my personal appreciation of Mrs. Minter of their office force, who has been to us a friend at court and has helped us over many hard places.

To Miss Durward, our President, to whom I am personally indebted for the privilege of having served you in these past months, I am most grateful. For the confidence she expressed by the appointment I am forever her debtor. It has been a particular pleasure to work with her because her supervision of the work has been intelligent supervision. There is always satisfaction in working with one who thinks a problem out.

The work to me has been a pleasant task because it has brought me into relationship with the members of this Sisterhood which for so many years has held a great place in my heart and life.

Report of Record Trustees,—Mrs. Alice S. Miller:

Your Board of Record Trustees submits the following report:

After the Supreme Chapter Convention held in Omaha, October, 1917, Mrs. Mary D. Lawrence, who had for two years served so efficiently as Chairman of the Board of Record Trustees, retired as her term of office had expired. The President, Miss Durward, appointed Miss Rosa M. Schoder, of Denver, Colorado, as the third member of the board and she, with Mrs. Sara D. Reuling of Wymore, Nebraska, and myself, constituted the Board of Record Trustees for the past two years and we have handled all the business in connection with the publishing of the P. E. O. Record.

The first question for our consideration was the contract for the publishing of the Record. At Supreme Chapter convention it has been voted to recommend that the following bid of the Claflin Printing Company at Lincoln, Nebraska, be accepted.

tion of the issue of February, 1918, and ending with the issue of January, 1920.

At that time this bid seemed to be the better one to accept as the price quoted was for a two-year contract. The bid of the Gate City Press of Kansas City, Missouri, who had published the Record since August, 1914, and whose work had been satisfactory, was \$391.45 per month less on the 19,000 copies than the bid of the Claflin Printing Company, but the price they quoted was for one-year contract only while the bids sent in by other firms were quoted subject to market changes.

After going over the matter thoroughly, making a careful study of the paper market and the conditions which might affect it, your Trustees unanimously decided it would not be for the best financial interest of Supreme Chapter to change publishers at that time and pay \$391.45 per month more to the Claflin Printing Company in order that we might have the two year contract. We felt confident that money could be saved by allowing the Gate City Press to continue doing the work even though a contract would have to be made for each year. This question was taken up with Miss Durward, who also made a thorough investigation, and she, in turn, consulted with the Executive Board of Supreme Chapter. They voted to allow the Board of Record Trustees to make the best contract they possibly could. After having been given this authority to act, the following bid of the

Gate City Press of Kansas City, Missouri, was accepted:

A bond in the sum of \$750.00 was executed by them as a guarantee for the faithful performance of their duties, and a contract was signed with them for one year beginning with the publication of the issue of February, 1918, and ending with the issue of January, 1919.

During the fall of 1918 it was necessary to obtain bids for the publishing of the Record for the second year. Three firms sent in bids but the lowest one and the one which was accepted, with the approval of the President of Supreme Chapter, was that made by Gate City Press of Kansas City, Missouri, as follows:

For the issues of February, March and April, 1919, using "20th Century English Finish" Book stock,

Another bond for \$750.00 was executed by said publishers and a contract signed for the second year's work.

Publishing a magazine during war times and trying to keep prices on a satisfactory basis, with the paper market rapidly advancing—in fact, not knowing whether the paper could be purchased at all—is no small task and your trustees worked hard and figured closely in order to have the work done as economically as possible. Now, for our two years' work, we bring to you

a saving of approximately \$900.00 as a result of placing this contract as we did.

Contracts were sent to Mrs. Rogers, Editor, for her signature and also to Mrs. Reeves who was appointed Editor after the death of Mrs. Rogers in February, 1918.

As the question of advertising had been left to the option of the Board of Record Trustees, it was decided to try and arrange to carry ads providing the Post Office Department at Washington would permit the Record to be entered under an act which would allow advertising. Your Chairman took up this question with the Post Office officials at Kansas City, who at that time felt quite confident that we would be permitted to carry ads in the Record. Application was accordingly made for the necessary permit.

Gate City Press stated that they would like to take charge of the advertising on the basis of 35 per cent of all money collected for ads they to pay all expenses in connection with soliciting, collecting and conducting the advertising work. We decided to permit hem to do the work on this basis and they placed in the Record notice soliciting ads at the following prices:

The Post Office officials requested a copy of the Record which would contain a sample ad. This request was complied with and an ad put in the Record for two months, for which we received \$20.00 which amount was turned over to the Treasures of Supreme Chapter.

After extended correspondence with the Post Office Department, with endless explanations concerning the laws and rules of our Sisterhood, and after waiting many months for the decision, we were finally advised that it would be necessary to make changes in the Constitution before the Rec-

ord could be entered under an Act which would permit the carrying of ads. very kindly, stated, however, that if assurance could be given that the necessary action to conform to the requirements of the Post Office Department would be taken at the next convention of Supreme Chapter, the publication would be accepted in the interin at the regular second class rate of postage with the privilege of carrying advertisements. Your Trustees, feeling they had no authority to guarantee that the necessary changes in the Constitution would be made by Supreme Convention, decided unanimously that advertising in the Record would have to be given up for the present and the correspondence from the Post Office Department, with suggested changes in the Consituation, was turned over to the Revision Committee for whatever action they might consider it best to take.

As it had been recommended that a new cover plate for the Record be purchased your Trustees decided it would be well to change the cover design. Some designs had already been submitted and from these we selected one which we thought would be saisfactory. A plate was ordered made and request sent to the publishers that a sample of the new cover be submitted to the Trutees before it appeared on the Record. This request was not complied with and when in February, 1918, the design appeared on the Record it was a great surprise to your Trustees to find it was not like the original design but had been changed so it was not at all satisfactory to the Trustees and we felt it would not be satisfactory to the Sisterhood. Steps were immediately taken to arrange for a design which would make a dignified looking cover and a notice was put in the Record requesting that designs for a cover be submitted. good ones were received but the design which was finally chosen was one drawn by Miss Sylvia T. Holstrom of Havelock, Nebraska-a P. E. O. Sister. Your Trustees feel greatly indebted to Miss Holmstrom because of the great effort she made to have the design perfectly satisfactory. Several suggestions were sent to her and she made altogether four drawings of the design in order to carry out these suggestions, the last one being an enlarged copy accurately

drawn for the engraver. This requided a great deal of time and work on the part or Miss Holmstrom.

The new cover appeared on the February, 1919, issue of the Record and has been used since that time. The following month the back cover was colored so as to harmonize with the front one.

The mailing list is now in excellent shape, due to the hard and faithful work of our Editor. One can hardly imagine the time Mrs. Reeves has spent and the work she has done in order that this list might be correct. Up to August 20, when the last comparison was made by Mrs. Reeves with Mrs. Weber's active list by States, a total of 2,254 names improperly placed on the list had been removed, and at that date there was a difference of only thirteen names on the two lists.

When the active lists were made out by the local Chapters March 1st, of this year, Mrs. Reeves asked for a duplicate copy. These have helped to correct the mailing list as they furnished a standard by which to check.

The money saved the Sisterhood because of the list having been corrected has, I believe, been more than enough to pay the Editor's salary.

In August, 1919, Record your Trustees advertised for bids on the work of publishing the Record for the coming two years and several have been received. Feeling that it is the duty and privilege of each Board of Trustees to place their own contract, we would recommend that the placing of the contract for the publishing of the Record for the next two years be left to the incoming Board of Record Trustees.

I will now give a personal report. As Chairman, I have attended to all correspondence, have submitted to each member of the Beard of Record Trustees every question which needed attention and have sent to the President of Supreme Chapter a copy of each letter written the Board so she would be fully informed as to what was being done.

It was my duty to draft and sign the contracts with the publishers and arrange with them to execute their bond also to draft the contracts with the Editors.

Have examined all bills from the publishers, comparing them with the Editor's state-

ment of the number of Records ordered, and have sent them on to our Supreme President for payment.

It was necessary for me to make two trips to Kansas City to attend to various matters of business.

The work done by our publishers has been very satisfactory and we feel they have given us good service.

The Record has been published each month, not even missing an issue after Mrs. Roger's death, due to the fact that Miss Durward, in her capable manner, edited the March, 1918, number.

Our Supreme President has in every way been a great inspiration and help to the Record Trustees nd we feel very thankful to her for her service and conusel.

Our work with the former Editor, Mrs. Rogers, while only just begun, was very pleasant in every way and it was a great sorrow to us when she passed away. She was deeply interested in the Record and the work connected with it and was in Kansas City working on the mailing list and making corrections when taken ill and for this reason was unable to complete the work.

The appointment of Mrs. Reeves as Editor was very satisfactory to the Record Trustees and there has been perfect cooperation between us, making the work a pleasure. We are greatly indebted to Mrs. Reeves for many helpful suggestions.

To Mrs. Reuling and Miss Schoder I am under great obligation for faithful service. They have at all times been prompt and efficient in their work and I ask each of them to accept the thanks from a heart filled with love and gratitude.

It was with deep regret I learned from Mrs. Reuling that, on account of illness, she felt it would not be possible for her to remain on the Board after this Convention time. During the past four years, since she has been on the Board, she has given most excellent service and I regret exceedingly that she is unable to take up the duties of Chairman during the next two years. Mrs. Reuling's resignation leaves Miss Schoder as the only one of the present Board who will continue with the work; she has, however, proved herself capable in every way and in surrendering the work to her and her Board

it is with a feeling of assurance that the Record work will prosper under ner guidance.

Report of Chairman of Board of Trustees of the P. E. O. Educational Fund; Viola R. Whittlesey.

At the time of our last report to you, in October, 1917, we had 268 girls on our list. Today we report to you a total of 355 with about 40 applications awaiting the decision of the Board, most of which will no doubt be granted. This is an increase which was made possible only by the substantial and really splendid increase in contributions.

It is with pardonable pride that we may think of the response to our efforts along this line for we have given to this fund, in two years, a sum equal to that given during the previous ten years. By far the greater part of that increase has been contributed during the year just past. In January, 1918, your Supreme President, Miss Durward, summoned me to Denver for a conference on the Educational Fund work. At this time we decided upon a card catalog system for use in the work and I have since then catalogued all loans, beginning with my term of office as chairman in 1915, at the same time it was determined to send the permanent Record Book to Mrs. Bailey, the second member of the board, thus relieving the chairman of that part of the work.

We decided upon slips containing a set of busines suggestions to be sent the applicant. Certain duties were outlined for the third member of the Board, Mrs. Dawes, consisting chiefly of following up the careers of our girls after they are thru college, thus keeping in touch with the partical results of our loans.

It was also decreed that the Record be the means of disseminating items of interest regarding the Educational Fund work. The heavy correspondence of the chairman should not be added to by having to answer questions by letter when the information may be found by all in the Record. This too, would eliminate the expense of having pamphlets printed. The Record is our official organ and we should use it for such purposes. This will necessitate a more careful reading of the Record and the keeping of at least one file in each chapter for reference.

During the past two years I have received more than three thousand letters and have written more than five thousand. I have prepared Educational Day Programs for 715 chapters, in nearly all instances writing a personal appeal for larger contributions, and a larger interest.

Since going to California I have given talks to a number of chapters there and found every one eager to hear of the work at first hand. This work has long since ceased to be an experiment.

We are indebted to Mrs. Edith Orr of Sioux City, Iowa, for her efforts to assist the fund for she wrote and presented a playlet at the Iowa Convention last May, being an exposition of our work. This playlet, she afterwards presented to our board for us to have copies made for use in chapters wishing to present it. As it was about time for all chapters to disband for the summer, it was decided to have a few copies made and to sell them to the chapters wishing them for one dollar each. But twelve chapters made requests for it, the reason being as before stated that meetings were not being held.

We have also to report that Mrs. Anna Harris of Chaper O, St. Louis, Mo., has in her will, left a bequest of one thousand dollars to the P.E.O. Educational Fund This is in line with Chapter O's splendid interest in this work, for it was O. Mo., you know, who really laid the foundation for this fund when her member, Mrs. C. D. Lukins, presented, at the Lincoln convention, in 1903, the idea of a P. E. O. day at the St. Louis Exposition. Supreme convention voted to have such a day and a method was devised for raising the necessary money for the enterprise. The sum left over from this fund, formed the nuclieus for our Educational Fund of today. The results achieved are splendid beyond our expectations.

We find that with everything else the cost of a college education has increased and it is ever harder and harder for a girl to get through on limited means. The sum

asked for now is very often in excess of our maximum, and many times a girl who, if given the necessary training would be of great service in a certain line of work, must give up her ambition because the sum we lend is insufficient.

As our fund has grown to such an extent and will keep on growing, I believe it would be the part of wisdom for us to increase the maximum and, in specific cases allow the Board, with the approval of the Surreme Board to increase the loan, where it is believed the applicant is fitting herself rather to serve humanity than to add to her own earning power. To illustrate such a case I will read you the letter of such a girl who gave her consent voluntarily, for me to use her name if I so desired:

"I received at the proper time, the second installment of the loan which the P. E. O. is making me.

"In six weeks I shall have finished my year's work here and shall take up the work of the summer school. At the end of the whole time, I shall be ready for my senior year. When I began work here I was not aware that I could by the year's attendance come within so little of finishing my entire course. But now that I am so near a degree I am anxious to finish-and at a larger school. I should command so much better position with the degree than without and would be able to choose my place of residence in these United States unhandicapped by the lack of a proper credential for the best work offered to my profession. Besides I am nearly thirty years old and must conclude longer delay in preparation for my work is inadvisable if not dangerous.

"With this in mind I am wondering if it would be possible to procure a further loan from the P. E. O. I understand that the largest loan made to one person is five hundred dollars, and as I have already negotiated for three hundred dollars I dare say that the other two hundred is all I could arrange for unless some exception could be made. I do not wish to seem greedy—but I see so plainly the wisdom of my finishing the work right now.

"My work in college progresses with a great degree of pleasure on my part. I am at present making a special study of the

Russian Revolution and I assure you it is most interesting. Some time in my life I hope to be able to strike some blows for the welfare of womanhood and childhood. I have already made a cursory study of rural school conditions in N. W. Iowa. During the year of 1914-1915 out of some 1473 children enrolled in the rural schools of one county only 1088 graduated from the 8th grade. Sometime I shall write a book, "The Poor Little Rich Children." Dear me I hope you will pardon such a diversion from the subject." *** I believe that granting this the loan she asks would be well worth while because of the service she would render humanity but under our present rules we can not do so. Think this over and be ready to consider the recommendation of the revision Committee regarding this.

Since our fund has doubled in the past two years, so has the work increased, so much so were it not for the thought of the good we are doing, it would be a real hardship. But it brings it's own pleasure in the coming in such close intimacy with the girls who have opened their hearts to us as soon as they realized that we are not a cold-blooded loan agency, but that we are doing this for them because we want to be of help to them, and above all that we do not consider them recipients of charity, but that we respect their dignity and admire the courage with which they are facing their problems.

Another source of gratification in the knowledge that nearly every one of our girls is thrilled with the ambition to help some other girl as soon as she has repaid her loan to us. One such, away up in Washington, has put her sister thru a two years normal course and gave to a dear friend the needed last year in college and is now teaching and repaying her debt. This loan, then, has been the means of a broader, richer life to three girls and no doubt to more as time goes on.

This is a momentous episode—the fiftieth anniversary of the organization of P. E. O. and it seems to me that these who are our most honored guests, these mothers of P. E. O. may with prideful rejoicing, feel that all this trained efficiency we have, thru these locals, turned out of college all over

the land—may be traced back and credit given to those girlish minds who were Godguided in that long ago. This work is the brightest ray from that star which was born in 1869.

Before closing, I wish to thank Miss Durward for all her kind helpfulness, her active interest in this work has been an inspiration. Also I wish to pay tribute to my coworkers, Mrs. Bailey and Mrs. Dawes. They have stood by lovingly and loyally and their counsel has been ever wise and just; and to Mrs. Bertha Clark Hughes, I give heartfelt thanks, for she has worked closely with me, has sought always to carry out plans as outlined by me, has put enthusiasm into the work which has borne good fruit. When I have requested any special work from her, she has acceded to my wishes with characteristic amiability.

My term of office expires with the close of this convention. While I have not fully realized my plans for the work, I have given to it the best I had to give, and I thank you,, (and Miss Prouty, who appointed me) for the privilege of serving in a work which so tremendously justifies the Sisterhood,—a work so permanent in it's results—a work which is a practical reality of a very beautiful dream.

Report of Treasurer of the Educational Fund, Mrs. Bertha C. Hughes: During the two years that I have served as Treasurer of the Educational Fund, I have completed the new set of books recommended by the Committee on Auditing at the last Supreme Convention, and now have a double entry system of bookkeeping, according to instructions. I endeavored to have this done by a firm of expert accountants, but found that it would cost from \$350 to \$700; so finally concluded to do the work for the Fund. The following statement shows the condition of the Fund on September 22nd, 1919, or to the time of auditing the records for October 1st, 1919:

Report of the Budget Committee:

In making this report may 1 say that there is no doubt that the past two years nave been the most trying, from a financial standpoint, that organizations have ever experienced because all commodities have gone so exceedingly high; consequently to quote expense accounts of other years in comparison is impossible.

We opened the books of the present regime with \$4,155.00 in our treasury while today the expense of this Convention is paid we have \$3,214.09, practically \$1,000.00 less than we had two years ago.

Naturally our magazine is our big expense, having spent since November, 1917, to September, 1919, \$15,517.73 for salary, printing and posting alone, with an additional amount of \$1,656.06 for other things connected with the work of the magazine.

Our supply department comes next in outlay but we must remember the amount here expended is returned to the treasury in small amounts. The expenditures up to September for this department have been \$1,987.50 and the amount from this department turned back to the treasury is \$792.87. You see we have an investment of \$1,000.00

Total expenditures according to the Treasurer's report which you have in your hand has been \$23,441.21 while total income \$20,259.00.

Since we are so far below our usual amount to turn over to our next board you committee recommends raising the Supreme ones from \$.50 to \$1.00 per capita, which will bring up the total income to \$20,798.00.

We would also recommend the budget cover the Educational Fund and that all the expense of administering the fund be paid from said fund.

We therefore recommend the budget to contain the following items:

- 4. To facilitate the work of bringing the sections before the convention we recommend that some officer of the board be named whose duty it shall be to move the adoption of all proposed sections.

Moved by Mrs. Miller, Iowa, and seconded that this sectionbe adopted, "To facilitate the work of bringing the sections before the convention we recommend that some officer of the board be named whose duty it shall be to move the adoption of all proposed sections." Motion carried.

The chair appointed Mrs. Abrams to conform with section just adopted.

Preliminary report of the revision committee, Miss Ida B. Johnson:

Two years ago when this committee was appointed, it seemed to me that a most sacred as well as overwhelming duty was laid upon me. At that time we were at the crisis of our nation's life; all hearts were torn in sympathy with suffering humanity; men and women were offering their lives a vicarious sacrifice.

Because of this universal interest our own individual life and plans seemed insignificant, as well as those of our sisterhood. It seemed to your committee that pernaps this was not the time to revise the constitution. No one seemed to be thinking about a constitution for the P.E.O. Sisternood; all hearts were too full, fingers too busy with bandages and comfort kits. Then there were changes in the committee because of inability of three members to serve. Miss Durward appointed Mrs. Grace R. Parks of Illinois on the committee and considered it wise to leave the work to three members instead of five as originally appointed, owing to the great increase in all expenses connected with the work.

About four months elapsed before we were really in shape for work; then everything began to grow brighter with the hope of peace and we began our work with enthusiasm.

From the beginning it has been the purpose of this committee to produce for our Sisterhood just such a constitution as our sisters wanted; to this end we desired to know your wishes. First, I had the priviof going over our old constitution with our president who had the vision to see the necessity for this revision, and who had appointed to this committee, our own Mrs. Drake, and of noting all suggestions she had to make.

This year we were able to report to every State convention, the progress we had made and we received much help from the discussion and suggestions and for all we are grateful. Miss Durward met with us twice and gave us the benefit of her help and splendid judgment.

We put in eighteen months of hard work, writing and re-writing, changing here and adding there, trying always to incorporate the wish of the majority, as it came to us.

Today we bring you the result of our effort. We have given our best thought to this work, and we beg you to consider it carefully. We want it to meet every need and we will welcome all changes that will make it more perfect.

Some requests came to us which conflicted with those which might be termed majority requests, since they represented the wish of many, and could therefore not be included; many suggestions left much to be worked out and to this end your committee has labored unceasingly. If we have approached your desires, have interpreted the needs of a great orgnization such as ours,

in a way which shall uphold our high standards and yet administer the affairs of our Sisterhood in a kind, sisterly way, we shall be happy and richly rewarded.

We nave found it necessary in the past, to change the various blanks used by our sisternood and as this necessitates frequent reprinting of the entire constitution, we have stricken all blanks from the constitution and placed them in the by-laws.

Miss Durward ruled that this revision being a complete remaking of our constitution, did not come under laws governing amendments, and therefore it was not necessary to present it in that way.

We therefore have the honor of presenting it to you.

Report of the revision committee.

The articles were read and adopted, section by section, as follows:

Art I. Name.

The name of this organization shall be the P. E. O. Sisterhood.

Moved by Mrs. Abrams and seconded Art. I be adopted as read. Motion carried.

Art. II. Objects and Aims.

Sec. 1. The objects and aims of this Sisterhood shall be general improvement, which shall comprehend more especially the following points:

To seek growth in charity toward all with whom we associate and a just comprehension and adherence to the qualities of faith, love, purity, justice and truth.

To seek growth in knowledge and in culture and to obtain all possible wisdom from nature, art, books, study, society, and to radiate all light possible by conversation, by writing and by the right exercise of any talent we possess; to aim at self-control, equipoise, and symmetry of character and temperance in opinions, speech and habits.

Moved and seconded that Art. II, Sec. 1, be adopted as read. Motion carried.

Sec. 2, It shall be the chief duty of every member to consider thoughtfully the full import of P. E. O. This will include a watchful eye as to each other's standing in the community, a careful consideration of feeling when speaking, a determination to do all we can at all times and under an circumstances, to promote each other's interests.

Moved and seconded that Art. II, Sec. 2, be adopted as read. Motion carried.

Art. III. Divisions.

Sec. 1. For the purpose of systematic government this organization is divided into the national chapter, state chapter and subordinate chapters.

Moved and seconded that Art. III, Sec. 1, be adopted as read.

Moved by Mrs. Irish and seconded this section be amended by striking out the word "national" and substituting the word "supreme." Amendment carried.

Motion as amended, carried.

Sec. 2. For the purpose of greater unity in government, subordinate chapters shall be placed in districts under the direct supervision of a district organizar appointed by the supreme president and ratified by the executive board of the supreme chapter.

Moved and seconded that Art. III, Sec. 2, be adopted as read. Motion carried.

PART ONE

The Supreme Chapter.

Art. I. The Supreme Chapter is the name of the highest body of the P.E.O. Sister-hood.

Moved and seconded Art. I be adopted as read. Motion carried.

Art. II. Membership.

Sec. 1. The Supreme Chapter shall consist of all persons who have been or may hereafter be regularly admitted to membership in the local chapters of the Sisterhood.

Moved and seconded Art. II, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The management of the affairs of the Supreme Chapter shall be vested in an executive board to consist of a president, first vice-president, second vice-president, organizer, recording secretary, corresponding secretary and treasurer.

Moved and seconded that Art. II, Sec. 2, be adopted as read. Motion carried.

Sec. 3. The members of the executive board shall be elected at the Biennial Convention of the Supreme Chapter and shall hold office for that term or until their successors are elected, installed and qualified.

Moved and seconded Art. III, Sec, 3, be adopted as read. Motion carried.

Sec. 4. All conventions of the Supreme Chapter shall be composed of the executive board and the following persons:

All Past Supreme Presidents when active. All Presidents of State Chapters.

All Past Presidents of State Chapters when active.

The Editor of The Record.

The Surviving Members of the Original Seven.

One delegate from each Subordinate Chapter, (being the President when practicable.

One delegate from every three chapters in a state where a state chapter exists, to be chosen by said state chapter at its last convention previous to the Supreme Chapter Convention.

Moved and seconded that Art. II, Sec. 4, be adopted as read.

Moved by Mrs. Bradley, Missouri, and seconded this section be amended to include State Organizers as members of the Supreme Convention when present. Amendment lost.

Original motion carried.

Art. III. Eligibility.

Sec. 1. No person shall be elegible to any office in the Supreme Chapter unless at the time of her election she shall be an active member of some chapter under its jurisdiction. No person shall be eligible to the office of president, first vice-president or organizer, who has not been duly elected and served as president of a State Chapter.

Moved and seconded that Art. III, Sec, 1, be adopted as read. Motion carried.

Sec. 2. All delegates to the convention except officers, shall present credentials to obtain a seat and vote in the convention.

Moved and seconded Art. III, Sec. 2, be adopted as read. Motion carried.

Art. IV. Meetings.

Sec. 1. A convention shall be held biennially, at such time and place as may be designed in the by-laws, unless by reason of emergency the president shall see fit to change the same; provided, the biennial meeting shall not be omitted.

Moved and seconded Art. IV, Sec. 1, be adopted as read. Motion carried.

Sec. 2. Special meetings of the executive board may be called by the president, at such time and place as she may order, setting forth the business to be considered, and no other business shall be transacted. A majority of the executive board shall constitute a quorum.

Moved and seconded Art. IV, Sec. 2, be adopted as read. Motion carried.

Art. V. Quorum.

A majority of all members entitled to representation in the convention is required in order to constitute a quorum for the transaction of business.

Moved and seconded Art. V be adopted as read. Motion carried.

Art. VI. Voting.

Sec. 1. Each member of the convention, when present, shall be entitled to one vote in each proceeding of said convention.

Moved and seconded Art. VI, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The ayes and nays on a question shall be expressed by the words pro and con.

Moved and seconded Art. VI, Sec. 2, be adopted as read. Motion carried.

Art. VII. Powers and Duties.

Sec. 1. The Supreme Chapter has power to establish chapters in all states, districts, territories, provinces, and countries at its discretion.

Moved and seconded Art. VII, Sec. 1, be adopted as read. Motion carried.

Sec. 2. It shall assign the limit of privileges of state chapters and settle controversies that may arise in state or subordinate chapters.

Moved and seconded Art. VII, Sec. 2, be adopted as read. Motion carried.

Section 3. It may suspend or expel state chapters for violation of its laws or for conduct contrary to the principles of the P. E. O. Sisterhood.

Moved and seconded Art. VII, Sec. 3, be adopted as read. Motion carried.

Sec. 4. It may grant or withhold charters for new State or Subordinate Chapters and may revoke dispensations or charters.

Moved and seconded Art. VII, Sec. 4, be adopted as read. Motion carried.

Sec. 5. At each Convention it shall consider all of the official reports of its officers and members and the reports of State and Subordinate Chapters under its jurisdiction for the preceding two years.

Moved and seconded Art. VII, Sec. 5, be adopted as read. Motion carried.

Sec. 6. It shall elect its officers and may place members on Committees for such service as it considers needful.

Moved and seconded Art. VII, Sec. 6, be adopted as read. Motion carried.

Sec. 7. It shall examine into the condition of the finances and adopt such measures as may be necessary to increase the revenue.

Moved and seconded Art. VII, Sec. 7, be adopted as read. Motion carried.

Sec. 8. It shall have jurisdiction over and power to control the policy of the official magazine.

Moved and seconded Art. VII, Sec. 8, be adopted as read. Motion carried.

Sec. 9. It shall adopt such rules as may be necessary for the good of the Sisterhood.

Moved and seconded Art. VII, Sec. 9, be adopted as read. Motion carried.

The following recommendation was presented by Miss Durward:

"I recommend that a committee be appoint to prepare a ritual or rituals for consideration at the next Biennial Convention."

Further report of the Revisions Committee.

Art. VIII, Nominations, Elections, and Duties of Officers.

Three plans of election were submitted by the Revision Committee. The third was adopted. This plan is as follows:

Section 1. Nominations of Supreme Chapter Officers shall be made by informal ballot; the five receiving the highest number of votes shall be declared the nominees.

Moved and seconded Art. VIII, Sec. 1, be adopted as read. Motion carried.

Section 2. The nominee receiving the majority of votes upon the elective ballot shall be declared elected; but if one candidate receives a two-thirds vote on the nominating ballot, the nominating ballot may be considered the elective ballot and the nominee declared elected.

Moved and seconded Art. VIII, Sec. 2, be adopted as read. Motion carried.

Section 3. The officers of the Supreme Chapter of the P. E. O. Sisterhood shall be elected biennially by ballot, and shall hold their respective offices until their successors shall have been elected and installed, except the Treasurer, who shall retain the books and money only until her successor has qualified.

Moved and seconded Art. VIII, Sec. 3, be adopted as read. Motion carried.

Section 4. It shall be the duty of the President of Supreme to exercise as occasion may require, all the rights pertaining to her office; to have a watchful supervision over all of the Chapters, State and Subordinate, and to see that all the laws of the Sisterhood are observed, and that the work and discipline are uniform throughout its jurisdiction.

Moved and seconded Art. VIII, Sec. 4, be adopted as read. Motion carried.

Among the special duties are the following:

To preside at all meetings, convene the Executive Board, appoint all committees and fill all vacancies not otherwise provided for.

To visit or preside at any chapter and give such instructions as the good of the Sisterhood may require, always adhering to the Constitution.

To decide, in cooperation with the Supreme Organizer, Subordinate territory into convenient districts, and to assign district organizers to the same.

To appoint three Boards of Trustees to have supervision over the supply department, the Educational Fund, and publications, respectively. Each of these Boards shall consist of three members. The chairman shall be a member of the Executive Board of the Supreme Chapter and shall be appointed biennially; the tenure of office for the other two members shall be four years. No two members of said Boards shall be residents of the same state.

To grant dispensations, when a convention is not in session, for the organization of a State Chapter when said state has qualified and for new Chapters where no State Chapter exists; such dispensation to be in force until the next biennial Convention.

To arrange with the chapter entertaining the convention, the time, program and guards for the convention; she shall send notice of the convention, including time and place to the official magazine the month preceding the month of meeting.

To conduct the installation ceremony or authorize her proxy to do so.

It is the duty of the Supreme President to complete the work of the term for which she was elected and in case of removal from office or resignation she forfeits her right to a Past President's Credential.

Stetion 5. The Vice Presidents, shall according to rank, in the event of death, removal from office or resignation, become President. In case of absence or physical disability of the President they shall act as President.

Moved and seconded Art. VIII, Sec. 5, be adopted as read. Motion carried.

Section 6. It shall be the duty of the organizer to have supervision over the work

of State Organizers and all Subordinate territory.

In order to facilate the growth of the Sisterhood, she shall consult with the President regarding the division of subordinate territory into districts convenient for work and when the President has made such divisions and appointed District Organizers, she shall instruct them and direct their work, receiving from them all petitions for new chapters with recommendations for organization.

If, after investigation, the organizer sends a favorable report to the President with the petition, the President of Supreme Chapter may, if she approves, grant a dispensation to organize a new chapter. When a dispensation has been granted, the organizer may direct the District Organizer or a proxy appointed by President and Organizer to proceed with the organization.

When a request is made for a new chapter in a town where one or more chapters already exist each chapter shall be notified immediately by the Supreme Organizer that such request is pending.

Each chapter in subordinate territory shall be inspected every two years by the Organizer, District Organizer or an authorized proxy.

At the meeting for inspection she shall examine all books and the by-laws of said chapter, inspect all ritualistic work except election and installation of officers. She shall instruct in the secret work and see that the work is uniform throughout her jurisdiction.

The organizer shall keep the President advised as to the condition of all chapters in her jurisdiction and shall render a full account of her work and the growth and interest in all chapters in her jurisdiction at the next convention following her election.

Moved and seconded Art. VIII, Sec. 6, be adopted as read. Liotion carried.

Sec. 7. The Recording Secretary shall keep a record of the proceedings of the convention. It is her duty to read all papers, not correspondence; to notify committees of their appointment and of the business referred to them; to have proceedings of the convention printed and authenticate them by her signature and the seal of the Sisterhood.

When a roll call vote is demanded she

shall note the answers pro and con. She shall keep a record of all transactions of the Supreme Chapter and shall furnish official printed copies of by-laws, amendments, and the official magazine containing minutes of the last convention of the Supreme Chapter to the following:

Each officer of the Supreme Chapter.

Recording Secretary of each State Chapter for the President of every chapter in her state.

District organizers for the President of every chapter in their district.

A sufficient number to the Supply Department to add to the supplies of new chapters.

She shall ascertain the number of copies of the official magazine containing the minutes of the Supreme Chapter Convention that will be needed and report the same to the Supreme President immediately ofter Convention.

It shall be her duty to insert in the minutes when necessary, a Memorial Page as a tribute to our dead.

Moved and seconded Art. VIII, Sec. 7, be adopted as read. Motion carried.

Sec. 8. The corresponding secretary shall conduct the correspondence of the Supreme Chapter, read at Convention all necessary correspondence, take the roll and report absentees. She shall keep a record of the membership of all chapters in the Sisterhood and shall send a list of Treasurers of subordinate chapters to the supply department. She shall notify the corresponding secretary of each subordinate chapter of expulsions.

When a state or subordinate chapter is disbanded she shall instruct said chapter to send to the Supply department the following property: and to report to her in writing when same has been done:

Charter, President's and Corresponding Secretary's books of records, all ceremonies and all things used in ceremonies, all blanks, P. E. O. electrotype. All other things shall be destroyed.

Moved and seconded Art VIII, Sec. 8, be adopted as read. Motion carried.

Sec. 9. The Treasurer immediately following the convention shall apply for a security bond to be paid for by the Supreme Chapter for the amount handled by her predecessor, and shall file same with the Recording Secretary within thirty days after her election.

No funds shall be paid into her hands until such bond has been approved by the President. She shall pay all drafts ordered by the Supreme Chapter or its Executive Board and signed by the President and Recording Secretary.

When a convention is not in session no warrant shall be paid by the Treasurer unless such warrant has been authorized by the Supreme Chapter or by the unanimous vote of the Executive Board and signed by the President and Recording Secretary.

She shall render to the Supreme Ccapter Convention a summary of all money received and disbursed by her. She shall publish in the official magazine at the expiration of each year of her service, a report of all money received and expended by her.

In January she shall notify all members of disbanded chapters in her jurisdiction that the annual dues are payable in February and shall report to the Corresponding Secretary all such members paying dues.

Moved and seconded Art. VIII, Sec. 9, be adopted as read.

Moved by Mrs. Abrams and seconded the first part of the section be amended to read, "The Treasurer immediately following Convention, shall apply for security bond, to be paid for by the Supreme Chapter for an amount equal to the estimated revenues to be derived from dues to be handled by her, and shall file same with the Recording Secretary within thirty days after her election."

Amendment carried.

Section as amended, carried.

Sec. 10. It shall be the duty of those appointed by the Supreme President to act as Guards to see that the doors are closed, that the place of meeting is in order, that all within the room are entitled to remain, that children over two years of age are excluded and that no one enters without the proper password.

Moved and seconded Art. VIII, Sec. 10, be adopted as read. Motion carried.

Sec. 11. The Editor of the official magazine shall be elected by ballot at each convention of the Supreme Chapter. Any person wishing to be a candidate for the Editorship may file with the Recording Secretary, proof of her ability to serve as editor which

information shall be read to the Convention before the ballot is taken.

Moved and seconded Art. VIII, Sec. 11, be adopted as read. Motion carried.

Sec. 12. The Executive Secretary shall be appointed by the President; said appointment to be ratified by the Executive Board.

No appointment shall be made until the President and Board have a satisfactory proof of the ability of such pesson to do the work of this office.

If satisfaction is not given, the Board shall have the power of removal from said office.

Moved and seconded Art. VIII, Sec. 12, be adopted as read. Motion carried.

Sec. 13. Each officer upon the expiration of her term of office shall deliver to her successor all paper and supplies in her possession, together with a tabulated list of same, for which she shall take a receipt.

Moved and seconded Art. VIII, Sec. 13, be adopted as read. Motion carried.

Art. IX. Executive Board.

Sec. 1. The officers of the Supreme Chapter shall constitute the Executive Board.

Moved and seconded Art. IX, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The duty of the Executive Board shall be to consult and advise during the biennial interval and to transact all business necessary to the interests of this Sisterhood. A majority of the Executive Board shall constitute a quorum.

Moved and seconded Art. IX, Sec. 2, be adopted as read. Motion carried.

Sec. 3. It shall have power to hear and determine all appeals from State Chapters, Subordinate Chapters and members when same are brought before it in accordance with the regulation with the Sisterhood, and to provide for the enforcement of its decisions.

Moved and seconded Art. IX, Sec. 3, be adopted as read. Motion carried.

Sec. 4. An official jeweler shall be appointed by the Executive Board; said jeweler to have sole authoriy to manufacture and sell to the Supply Department the P. E. O. emblem.

Moved and seconded Art. IX, Sec. 4, be adopted as read. Motion carried.

Art. X. Finances.

Sec. 1. Each state chapter shall pay to the Supreme Treasurer by April first an annual per capita tax of \$1.00 per active member; fifty cents of this to be the subscription to the official magazine.

Moved and seconded Art. X, Sec. 1, be adopted as read. Motion carried.

Sec. 2. Each subordinate chapter shall pay to the Supreme Treasurer by March 10, an annual per cauita tax of one dollar, fifty cents of this to be the subscription for the official magazine.

Moved and seconded Art. X, Sec. 2, be adopted as read. Motion carried.

Sec. 3. Persons desiring to form a chapter in subordinate territory, shall enclose with petition a charter fee of fifteen dolars.

Moved and seconded Art. X, Sec. 3, be adopted as read. Motion carried.

Sec. 4. The Executive Board may levy assessments upon all chapters for such sums as may be needed for its proper support, if emergencies arise.

Moved and seconded Art. X, Sec. 4, be adopted as read. Motion carried.

Sec. 5. The Supreme Chapter shall pay all expense of organizing and inspecting its Subordinate Chapters.

Moved and seconded Art. X, Sec. 5, be adopted as read. Motion carried.

Sec. 6. The Supreme Chapter shall furnish one set of supplies to every new chapter at the time of organization and shall pay the Supply Department the cost of the supplies sent.

Moved and seconded Art. X, Sec. 6, be adopted as read. Motion carried.

Sec. 7. The sum of twenty-five dollars shall be paid by the Supreme Chapter to the Treasurer of each State Chapter at the time of its organization.

Moved and seconded Art. X, Sec. 7. be adopted as read. Motion carried.

Sec. 8. The sum of twenty-five dollars shall be paid by the Supreme Chapter to the entertaining chapter at the organization of a state chapter.

Moved and seconded Art. X, Sec. 8, be adopted as read. Motion carried.

Sec. 9. The Supreme Chapter shall pay all incidental expenses, the printing of programs and rental of proper place in which to hold its biennial session.

Moved and seconded Art. X, Sec. 9, be adopted as read. Motion carried.

Sec. 10. The Supreme Chapter shall pay

Sec. 4. Chapters in a state where there is no State Chapter must receive their charters from the Supreme Chapter (see bylaws for adopted form).

Moved and seconded Art. XI, Sec. 4, be adopted as read. Motion carried.

Art. XII. Procedure.

All meetings shall be governed by Robert's Rules of Order.

Moved and seconded Ast. XII, be adopted as read. Motion carried.

Art. XIII. Amendments.

The Convention shall have power upon the concurrence of three-fourths of its members present at any regular meeting, to amend Part I, of this constitution; provided that any P. E. O. intending to submit a

motion relative to an amendment to the Constitution or Kitual shall give notice thereof in writing at least three months before the day on which the Convention shall assemble and thereupon the Kecording Secretary shall cause to be published in the official magazine a notice of the proposed amenaments. If the member fails to give such notice to the Recording Secretary, the proposed amendment may still be called up by consent of three-fourths of the members present, and acted upon if notice had been given. An amendment proposed at one Convention may, if desired, be postponed until the next, when it may be acted upon without further notice. The wording of a proposed amendment may be changed provided the change does not affect the spirit of the proposed amendment.

The adjourned meeting of Thursday morning called to order at 1:40 P. M. by President, Miss Durward.

Report of Revision Committee continued. Part II, The State Chapter.

Art. I. Formation.

Sec. 1. When there are nine chapters in any state, district, or territory, they shall obtain from the Supreme President a Dispensation and form an organization to be known as a State Chapter.

Moved and seconded Art. 1, Sec. 1, be adopted as read. Motion carried.

Sec. 2. Chapters desiring to form a State Chapter hall enclose with petition a charter fee of fifteen dollars. The form of petition shall be that adopted by the Sisterhood. (See by-laws for form).

Moved and seconded Art. 1, Sec. 2, be auopted as read. Motion carried.

Sec. 3. When a Dispensation has been granted, a meeting shall be called by representatives from all chapters petitioning for a scale Chapter. If the call is responded to by at least seven chapters, this shall constitute a quorum. Each chapter is entitled to two delegates. The President, if practicable, shall be one delegate and the other delegate shall be elected by her chapter.

Moved and seconded Art. I, Sec. 3. be, adopted as read. Motion carried.

Sec. 4. If at the time of a state organization, there are chapters under dispensation, charters may be granted them by the consent of the Executive Board of the Supreme Chapter.

Moved and seconded Art. I, Sec. 4, be adopted as read. Motion carried.

proxy, shall organize State Chapters, and proxy, shall orgnize State Chapters, and shall act as presiding officer until officers are elected and installed. The Supreme President shall be present when possible.

Moved and seconded Art. I, Sec. 5. be adopted as read. Motion carried.

Sec. 6. When the Convention is assembled at the time and place agreed upon by the petitioners, the dispensation shall first be read; credentials examined and approved; a resolution adopted agreeing to form a State Chapter; by laws adopted or a committee appointed tto formulate them; officers elected and installed.

Moved and seconded Art. I, Sec. 6, be adopted as read. Motion carried.

Sec. 7. A state chapter continues to exist as long as it includes three chapters. When the number becomes less than three it becomes extinct, and the chapters remaining pass directly under the control of the Supreme Chapter.

Moved and seconded Art. I, Sec. 7, be adopted as read. Motion carried.

Art. II. State Chapter.

Moved and seconded Art. II, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The management of the affairs of each State Chapter shall be vested in an

Executive Board to consist of a President, First Vice-President, Second Vice-President, Organizer, Recording Secretary, Corresponding Secretary, and Treasurer.

Moved and seconded Art. II, Sec. 2, be adopted as read. Motion carried.

Sec. 3. The members of the Executive Board shall be elected at the annual convention of the State Chapter and shall hold office for one year and until their successors are elected, installed and qualified.

Moved and seconded Art. 11, Sec. 3, be adopted as read. Motion carried.

Sec. 4. The Convention of a State Chapter shall be composed of the Executive Board and the following persons:

- 1. All surviving members of the Original Seven whose membership is in such State.
- 2. All Past Presidents of such State when active.
- 3. All Past Presidents of the Supreme Chapter when active in the State.
- 4. Such number of delegates from the local chapters as the by-laws of each State shall provide, the President of the chapter being a delegate when practicable.

Moved and seconded Art. II, Sec. 4, be adopted as read.

Moved by Mrs. Townsend and seconded that second part of Sec. 4, be amended to read, "All Past Presidents of said state when active. Amendment carried.

Motion as amended carried.

Art. III. Eligibility.

Sec. 1. No person shall be eligible to office in the State Chapter unless at the time of her election she is an active member of some chapter in said state. No person shall be eligible to the office of President, First Vice-President, Second Vice-President or Organizer, who has not presided over a Local Chapter as its duly installed President.

Moved and seconded Art. III, Sec. 1, be adopted as read. Motion carried.

Sec. 2. Delegates to State Chapter Convention except officers shall present credentials to obtain seat and vote in such Convention.

Moved and seconded Art. III, Sec. 2. be adopted as read. Motion carried.

Art. IV. Meetings.

Sec. 1. The State Chapter Convention shall meet annually at such time and place as may be designated in the by-laws, un-

less by reason of emergency the President shall see fit to change the same, provided the annual meeting is not omitted.

Moved and seconded Art. IV, Sec. 1, be adopted as read. Motion carried.

Sec. 2. Special meetings of the Executive Board may be called by the State Chapter President at such time and place as she may order, setting forth the business to be considered and no other business shall be transacted. A majority of the executive board shall constitute a quorum.

Moved and seconded Art. IV, Sec. 2, be adopted as read. Motion carried.

Art. V. Quorum.

A majority of all chapters entitled to representation in the state chapter convention is required to constitute a quorum for the transaction of business.

Moved and seconded Art. V, be adopted as read. Motion carried.

Art. VI. Voting.

Sec. 1. Each member of Convention, when present shall be entitled to one vote in each proceeding of said Convention.

Moved and seconded Art. VI, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The ayes and nays on a question shall be expressed by the words pro and con.

Moved and seconded Art. VI, Sec. 2, be adopted as read. Motion carried.

Art. VII. Powers and Duties in Convention.

Sec. 1. The State Chapter being the highest authority under the Supreme Chapter within the state of is charged with the government of all chapters within said state.

Moved and seconded Art. VII, Sec. 1, be adopted as read. Motion carried.

Sec. 2. It may assign the limit of privileges of its chapters and settle controverises that may arise between them.

Moved nd seconded Art. VII, Sec. 2 be adopted as read. Motion carried.

Sec. 4. It may grant or withold charters for new chapters within the state or may revoke dispensations or charters.

Moved and seconded Art. VII, Sec. 6, be adopted as read. Motion carried.

Sec. 5. It shall consider at the regular meeting all of the official reports of its officers and chapters for the preceding year.

Moved and seconded Art. VII, Sec. 7, be adopted as read. Motion carried.

Sec. 6. It shall elect its officers and delegates and place members on committees.

Moved and seconded Art. VII, Sec. 6, be adopted as read. Motion carried.

Sec. 7. It shall examine into the condition of the finances and adopt such measures as may be necessary to increase the revenue.

Moved and seconded Art. VII, Sec. 7, be adopted as read. Motion carried.

Sec. 8. It shall have power to adopt laws consistent with the Constitution of the P. E. O. Sisterhood.

Moved and seconded Art. VII, Sec. 8, be adopted as read. Motion carried.

Sec. 9. It shall send its by-laws previous to every Convention of the Supreme Chapter to a committee appointed by the Supreme President for inspection and correction; the report of said committee to be read in the Supreme Chapter Convention.

Moved and seconded Art. VII. Sec. 9, be adopted as read. Motion carried.

Art. VIII. Nominations, Elections and Duties of Officers.

Sec. 1. Nominations of State Chapter officers shall be made by nominating ballot; the five names receiving the highest number of votes shall be declared the nominees.

Moved and seconded Art. VIII, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The nominee receiving the majority of votes upon the elective ballot shall be declared elected; but if one candidate receives a two-thirds vote on the nominating ballot, the nominating ballot may be considered the elective ballot and the nominee declared elected.

Moved and seconded Art. VIII, Sec. 2, be adopted as read. Motion carried.

Sec. 3. The officers of a State Chapter shall be elected annually by ballot, and shall hold their respective offices until their successors shall have been elected and installed, except the Treasurer, who shall retain the books and money only until her successor has qualified.

Moved and seconded Art. VIII, Sec. 3, be adopted as read. Motion carried.

Sec. 4. It shall be the duty of the State President to exercise as occasion may require all the rights pertaining to her office, to have a watchful supervision over all chapters within the State and to see that all laws of the Sisterhood are observed and that the work and discipline are uniform throughout the state. Among the special duties are the following:

To preside at all meetings of the State Chapter, convene the Executive Board, appoint all committees and fill all vacancies not otherwise provided for.

To visit or preside at any Chapter within the State and give such instructions as the good of the Sisterhood may require, always adhering to the Constitution and laws of the State Chapter.

To grant Dispensions for the institution of new chapters when the State Chapter Convention is not in session; such Dispensation to be in force no longer than the next annual meeting of this chapter.

To arrange with the chapter entertaining the Convention time, program and guards for the Convention and shall send notice of the Convention including time and place, to the official magazine to be published the month preceding the month of meeting.

She may for good cause vary the time and place set by the State Chapter for holding its annual meeting.

To conduct the installation ceremony, or authorize her proxy to do so.

It is the duty of the President to complete the work of the term for which she was elected. In case of removal from office or resignation she forfeits her right o a credential.

Moved and seconded Art. VIII, Sec. 4, be adopted as read. Motion carried.

Sec. 5. The Vice-Presidents shall according to rank, in the event of death, removal from office, or resignation, become the president. In case of absence or physical disability of the President she shall act as President. Should a vacancy occur in the office of First Vice-President it shall be filled by the Second Vice-President. At all times they shall perform such duties as may be assigned them.

Moved and seconded Art. VIII, Sec. 5, be adopted as read. Motion carried.

Sec. 6. It shall be the duty of the State Organizer to receive petitions from the President relative to forming new chapters within the State, to examine into the feasibility of such action and to report her views to the President. It shall be not duty to

recommend place where she considers it advantageous to form new chapters; to officially visit the Chapters of the State according to the by-ltws of said State Chapter, examine all books and by-laws and inspect all ritualistic work, except election and installation of officers.

She shall instruct in secret work and see that chapter work is uniform throughout the state.

When a request is made for a new chapter in a town where one or more chapters already exist, each chapter shall be notified by the State Organizer that such request is pending.

Moved and seconded Art VIII, Sec. 6, be adopted as read. Motion carried.

Sec. 7. The Recording Secretary shall keep a record of the proceedings of the State Chapter Convention.

It is her duty to read all pepers, not correspondence, to notify committees of their appointment and the business referred to them, to have the proceedings of the Convention printed and authenticate them by her signature and the seal of the Sisterhood. When a roll call vote is demnded she shall note the answers pro and con. She shall keep a record of all transactions of the State Chapter and send an official copy of the minutes of the last State Chapter Convention to the following:

President and Recording Secretary of Supreme Chapter.

President and Recording Secretary of all State Chapters.

All officers of her State Chapter.

All Past Presidents of her State Chapter when active.

All Presidents of Local Chapters in her state.

Editor of The Record.

Executive Secretary.

Following the Supreme Chapter Convention, she shall send the official copy of the proceedings of the Supreme Convention to all Presidents of Local Chapters in her state.

It shall be her duty to insert in the minutes, whenever necessary, a Memorial Page, as a tribute to our dead.

Moved and seconded Art. VIII, Sec. 7, be adopted as read. Motion carried.

Sec. 8. The Corresponding Secretary

State Chapter, read at Convention all neccessary correspondence, take the roll and report absentees. She shall keep a record of the membership of her state and shall send a list of names of Treasurers in the state to the Supply Department. When notified of an expulsion she shall immediately notify every Local Corresponding Secretary in her state.

When a Local Chaper in the state is disbanded she shall instruct said chapter to send the following property and to report to her in writing when the same has been done:

Charter, President's and Corresponding Secretary's book of records, all ceremonies and all things used in ceremonies, all planks, P. E. O. Electrotype. All other things shall be destroyed.

Moved and seconded Art. VIII, Sec. 8, be adopted as read. Motion carried.

Sec. 9. The Treasurer immediately following Convention shall apply for a security bond, to be paid for by the State Chapter, for the amount handled by her predecessor and shall file same with the Recording Secretary within thirty days after election. No funds shall be paid into her hands until such bond has been approved by the State President. She shall pay all drafts ordered by the State Convention or its Executive Board. When the Convention is not in session no warrant shall be paid by the Treasurer except by unanimous vote of the Executive Board and signed by the President and Recording Secretary. In January she shall notify all members of disbanded Chapters in her state, that annual dues are payable in February and shall report to State Corresponding Secretary all such members paying state dues.

She shall give a complete record at the annual State Chapter Convention of all money received and disbursed by her.

Sec. 10. It shall be the duty of those appointed by the State President to act as Guards for Convention, to see that the place of meeting is in order, that all doors are closed, that all within the room are enti-

tled to remain, that all children over two years of age are excluded and that no one enters without the proper password.

Sec. 11. Each officer of the State Chapter, upon expiration of her term of office, shall deliver to her successor all papers and supplies in her possession, together with a tabulated list of same, for which she shall take a receipt.

Each of us undertook to gather the data from a certain number of states and individuals.

Ill health necessiated the resignation of Mrs. Lou Spencer and Miss Durward appointed in her stead Miss Abbie Burns of University Place, Nebraska.

Owing to the illness and death of her husband. Mrs. Anna B. Grimes asked to be excused from further duty. We feel that the Sisterhood is to be congratulated upon securing Mrs. Reeves for this undertaking and we are glad if we have been of assistance to her.

An informal invitation was extended by P. E. O.s of the State of Washington to meet with them in Seattle in 1923.

Report of the Revision Committee continued.

Article IX, (Part II). The Executive Board.

Sec. 1. The officers of the State Chapter shall constitute the State Board.

Sec. 2. It shall be the duty of the Executive Board to consult and advise during the annual interim and to transact all business necessary to the interests of the Sisterhood.

Moved and seconded Art. IX, Sec. 2, be adopted as read. Motion carried.

Sec. 3. It shall have power to hear and determine all appeals from members when same are brought before it in accordance with the regulations of the Sisterhood, and to provide for the enforcement of its decisions.

Moved and seconded Art. IX, Sec 3, be adopted as read. Motion carried.

Art. X. Finances.

Sec. 1. Each State Chapter shall fix a per capita tax upon the members of Local Chapters within its jurisdiction, provided always that an annual per capital tax of one dollar per member be paid from each State Chapter to the Treasurer of the Supreme Chapter.

Moved and seconded Art. X, Sec. 3, be adopted as read. Motion carried.

Sec. 2. The State Chapter may, in emergency, levy and assess upon its subordinate chapters such sums of money as are needful for its proper support.

Moved and seconded Art. X, Sec. 2, be adopted as read. Motion carried.

Sec. 3. The State Chapter shall pay such expenses of organizing chapters as each state may prescribe.

Moved and seconded Art. X, Sec. 3, be adopted as read. Motion carried.

Sec. 4. Persons desiring to form a new chapter in the state shall enclose, with petition, a charter fee of fifteen lollars, ten dollars of which shall be sent to the Treasurer of the Supreme Chapter.

Moved and seconded Art. X, Sec. 4, oe adopted as read. Motion carried.

Sec 5. Each state shall provide for all necessary expenses of its delegates to the Supreme Chapter Convention.

Moved and seconded Art. X, Sec. 5, be adopted as read. Motion carried.

Sec. 6. One set of supplies shall be furnished by the Supreme Chapter to every new chapter, free of expense, except postage, at time of organization.

Moved and seconded Art. X, Sec. 6, be adopted as read. Motion carried.

Sec. 7. All reports of State Officers containing accounts of receipts and expenditures of the funds of the State Chapter, and all action looking to the appropriation of funds, shall be referred to a committee on finance for examination, and no appropriation shall be made until after due consideration and report thereon of said committee.

Moved and seconded Art. X, Sec. 7, be adopted as read. Motion carried.

Sec. 8. The expense of printing programs

for convention and rental for hall in which convention is held shall be paid by the state chapter.

Moved and seconded Art. X, Sec. 8, be adopted as read. Motion carried.

Sec. 9. The State Chapter shall pay all necessary expenses incurred by the Executive Board in carrying on the work of the state.

Moved and seconded Art. X, Sec. 9, be adopted as read. Motion carried.

Sec. 10 Each local chapter shall pay to the State Treasurer the sum of one dollar for each reinstatement.

Moved and seconded Art. X, Sec. 10, be adopted as read. Motion carried.

Art. XI Discipline.

Sec. 1. Chapters or members of disbanded chapters under the jurisdiction of the state reported for discipline may be dealt with by the Executive Board as may seem advisable in order to maintain the high standard of the Sisterhood. Any member or chapter under discipline after the action of the Supreme Board has been approved by the next annual convention, may have the right of appeal to the Supreme Chapter whose decision is final.

Moved and seconded Art. XI, Sec. 1, be adopted as read. Motion carried.

Sec. 2. When a chapter is placed under discipline by the Executive Board, its members pass directly under the jurisdiction of said Board.

Moved and seconded Art. XI, Sec. 2, be adopted as read. Motion carried.

Art. XII. Dispensations and Charters,

Sec. 1. The President of State Chapters may, upon receipt of a petition for formation of a Chapter, issue the Dispensation for Local Chapter, which has been adopted by the Sisterhood. (See Supreme by-laws for adopted form).

Moved and seconded Art. XII, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The charters issued by the state chapter for the formation of Local Chapters shall be in the form which has been adopted by the Sisterhood. (See by-laws for adopted form).

Moved and seconded Art. XII, Sec. 2, be adopted as read. Motion carried.

Sec. 3. Should an organization of nine or more chapters be prospected in the district of Columbia, or any territory outside of the United States, it shall be the same as a State Chapter and shall be governed accordingly.

Moved and seconded Art. XII, Sec. 3, be adopted as read. Motion carried.

Art. XIII. Procedure.

All meetings shall be governed by Robert's Rules of Order.

Moved and seconded Art. XIII, be adopted as read. Motion carried.

Art. XIV. Amendments.

Amendments to part II may be proposed at any regular convention of the State Chapter, and if carried by a three-fourths vote, shall be reported by the Recording Secretary of said State Chapter to the Recording Secretary of the Supreme Chapter, who shall present them to the next convention of the State Chapter and if approved by a three-fourths vote, they shall become a part of the Constitution of State Chapters.

Moved and seconded Art. XIV, be adopted as read. Motion carried

Minutes of previous session were read and approved as read.

Report of Revision Committee continued. Part III. Governing Local Chapters in state and subordinate territory.

Art. I. Formation.

Sec. 1. All chapters must receive their charters from a state chapter or where no State Chapter exists, from the Supreme Chapter of the P. E. O. Sisterhood.

Moved and seconded Art. I, Sec. 1, be adopted as read. Motion carried.

Sec. 2. To form a chapter within the jurisdiction of the Supreme or State Chapter, there must be presented to the President of Supreme or State Chapter a petition, furnished by the Organizer of Supreme or State Chapter, which has been signed by not less than twelve resident women. (See by-laws for adopted form of petition.)

Moved and seconded Art. I, Sec. 2, be adopted as read. Motion carried.

Sec. 3. When a petition has been presented, investigated and reported on favorably by the organizer of Supreme or State Chapter the President of Supreme or State Chapter if favorable to the investigation and report, may grant dispensation and the organizer of Supreme or State Chapter or a proxy shall proceed immediately to form

chapter under dispensation, the organizer acting as chairman until officers are elected and installed.

Moved and seconded Art. I, Sec. 3, be adopted as read. Motion carried.

Sec. 4. When a chapter or dispensation for a new chapter has been refused, the subject may be revived by a new petition one year later.

Moved and seconded Art. I, Sec. 4, be adopted as read. Motion carried.

Sec. 5. When a chapter is desired in a city where one or more chapters already exist the organizer shall immediately notify each chapter that such request is pending.

Moved and seconded Art. I, Sec. 5, be adopted as read. Motion carried.

When the petition for said chapter has been reported on favorably by the organizer she shall notify the President of each chapter and the President shall then notify all active resident members of her chapter, and a meeting of each chapter shall be held separately for discussion of the advisability of such action. The written consent of twothirds of the resident active members of each chapter shall be secured and sent, together with an official list of the active membership of each chapter to the President of Supreme or State Chapter with the petition before dispensation may be granted. In a city where two or more chapters exist, each chapter is a separate body governed under the laws of the Sisterhood and its own by-

Sec. 6. A chapter under dispensation must receive its charter at the convention following, unless previously granted by the Executive Board. Until it receives a charter the chapter may send its delegates to convention, who, until a charter is granted, may enjoy the privileges of convention, except the right to vote.

Moved and seconded Art. I, Sec. 6, be adopted as read. Motion carried.

Sec. 7. The charter members of a chapter shall be dimited P. E. O.s when present and those initiated at time of organization.

Moved and seconded Art. I, Sec. 7, be adopted as read. Motion carried.

Sec. 8. Chapters shall not be organized in places of less than 1,500 population, said population to be determined by the latest Government census.

Moved and seconded Art. I, Sec. 8, be adopted as read.

Moved by Mrs. Wagnor, California, and seconded this section be amended by striking out the word "Fifteen hundred" and substituting the word "one thousand."

Amendment carried.

Motion as amended, carried.

Sec. 9. The chapters in every state, district, or province shall be designated by the letters of the alphabet in order of organization. When all the letters have been used, succeeding chapters shall be designated as AA, AB, etc., then BA, BB, and continuously in this order. The first chapter organized at Mt. Pleasant, Iowa, shall be known as Original A.

Moved and seconded Art. I, Sec. 9, be adopted as read. Motion carried.

Sec. 10. A disbanded chapter cannot be reorganized under its original charter or receive its original letter, but shall rank as a new chapter.

Moved and seconded Art. I, Sec. 10, be adopted as read. Motion carried.

Sec. 11. In case of the disbanding of a chapter the supplies of such chapter shall be disposed of, according to instructions received from the Corresponding Secretary of Supreme or State Chapter.

Moved and seconded Art. I, Sec. 11, be adopted as read. Motion carried.

Sec. 12. If a state chapter should disband its chapters pass at once under the jurisdiction of the Supreme Chapter.

Moved and seconded Art. I, Sec. 12, be adopted as read. Motion carried.

Sec. 13. If a local chapter should disband its members pass directly under the jurisdiction of the State Chapter or if in subordinate territory they shall pass under the jurisdiction of Supreme Chapter.

Moved and seconded Art. I, Sec 13, be adopted as read. Motion carried.

Sec. 14. If three-fourths of the active resident members of a chapter vote to disband, notice of such action shall be sent to the President of Supreme Chapter if in subordinate territory, or the President of State Chapter, who shall report same to the following convention where final action shall be taken.

Moved and seconded Art. I, Sec. 14, be adopted as read. Motion carried.

Sec. 15. When nine chapters have been formed in the same state, or territory outside the United States they shall form a State Chapter.

Moved and seconded Art. I, Sec. 15, be adopted as read. Motion carried.

Art. II. Officers and their duties.

Sec. 1. The officers of a chapter shall be President, Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Chaplain, and Guard.

Moved and seconded Art. II, Sec. 1, be adopted as read. Motion carried.

Sec. 2. It shall be the duty of the President at all meetings; to appoint all committees not otherwise provided for, to call special meetings, to confer personally, if possible, with candidates for membership, and to have special care for the interests of the chapter. She shall sign all warrants authorizing the payment of chapter funds. She shall become familiar with the use of all blanks and supplies and instruct each officer concerning same.

Moved and seconded Art. II, Sec. 2, be adopted as read. Motion carried.

Sec. 3. In the absence of the President, the duties of her office shall be performed by the Vice-President. If a vacancy occurs, the Vice-President shall become President.

Moved and seconded Art. II, Sec. 3, be adopted as read. Motion carried.

Sec. 4. The Recording Secretary shall keep a record of the date and proceedings of all meetings of the chapter, authenticating same by her signature. She shall sign all warrants authorizing the payment of Chapter funds.

Moved and seconded Art. II, Sec. 4, be adopted as read. Motion carried.

Sec. 5. The Corresponding Secretary shall conduct the correspondence of the chapters. She shall send the names of the officers of her chapter immediately after election to the Editor of the official magazine and to the Corresponding Secretary of the State or Supreme Chapter, if subordinate to it. After election of delegates she shall report their names to the President of Supreme or Seate Chapter and to the chapter entering convention. She shall immediately report each initiation, reception by dimit, acceptance of dimit granted by her chapter.

reinstatement, death, changes in membership, giving date thereof to the Supreme or State Corresponding Secretary.

In case of expulsion of a member from her chapter, or the reinstatement of an expelled member, she shall immediately send notice, with the date of such action, to the president, organizer, and corresponding secretary of the Supreme Chapter and the President, organizer, and corresponding secretary of every State Chapter and the Supply Department.

She shall send the annual report to the Supreme or State Corresponding Secretary on or before the tenth day of March.

She shall keep a complete record of the membership of her chapter, act as correspondent to the official magazine and send the invitation for membership. Upon the receipt of an acceptance of invitation to membership, she shall turn the initiation fee over to the Treasurer.

Moved and seconded Art. II, Sec. 5, be adopted as read.

Moved by Mrs. Reeves and seconded to amend the first and second paragraphs of this section by adding the words, "and to the Editor of the official magazine." Amendment carried.

Motion as amended carried.

Moved by Mrs. Henley and seconded that a rising vote of thanks be given the City of Denver for flowers and courtesies shown the P. E. O. Sisterhood in convention assembled. Motion unanimously carried.

Sec. 6. It shall be the duty of the Treasurer to receive and collect all dues and assessments of the members; to receive from the Corresponding Secretary the initiation fee; to order and deliver the pins; to pay out money as the chapter shall from time to time, direct, upon a warrant signed by the President and Recording Secretary. She shall report at the first meeting of every month as to all moneys received and expended by her. She shall keep a correct list of members of the chapter and of all accounts with them and a special roll of those entitled to vote. On or before the tenth day of March she forward the annual dues of her chapter and her annual report to the Treasurer of Supreme or State Chap-

Moved and seconded Art. II, Sec. 6, be adopted as read. Motion carried.

Sec. 7. It shall be the duty of the Chaplain to conduct devotional exercises at every regular meeting.

Moved and seconded Art. II, Sec. 7, be adopted as read. Motion carried.

Sec. 8. It shall be the duty of the Guard to see that the rooms are prepared for the meeting; that all doors are closed; that all within are entitled to remain; that all who enter give the password and that children over two years of age are excluded.

Moved and seconded Art. II, Sec. 8, be adopted as read. Motion carried.

Sec. 9. When the officers of a chapter are elected and installed it is their duty to memorize the P. E. O. ceremonies. There shall be meetings of oficers following election at such time and place as the President may designate, at which meetings the duties of officers shall be distinctly explained by the President and the several parts in secret ceremonies rehearsed, until each officer becomes perfectly familiar with the necessary ritualistic work.

Sec. 1. It shall be the duty of each member to faithfully perform the duties assigned her.

Sec. 2. The by-laws may be framed to meet the requirements of each locality provided they conform to the constitution.

Moved and seconded Art. III, Sec. 2, be adopted as read. Motion carried.

Sec. 3. The by-laws of every chapter shall be sent, previous to each convention of a State or Supreme Chapter to a committee appointed by the President of State or Su-

preme Chapter for inspection or correction. Said committee to report on by-laws at the following convention.

Moved and seconded Art. III, Sec. 3, be adopted as read. Motion carried.

Sec. 4. The by-laws of every state chapter shall designate the number of delegates to be sent to its State Convention, the President acting as one delegate when possible.

Moved and seconded Art. III, Sec. 4, be adopted as read. Motion carried.

Sec. 5. Every chapter in subordinate territory shall be entitled to one delegate in the convention of Supreme Chapter, the president acting when practicable.

Moved and seconded Art. III, Sec. 5, be adopted as read. Motion carried.

Sec. 6. Quotations from the Ritual or Secret work shall not appear in year books, papers, the official magazine or come before the public in any way.

Moved and seconded Art. III, Sec. 6, be adopted as read. Motion carried.

Sec. 7. The Local chapters shall present to each member at the time of initiation, a copy of the constitution. The State or Supreme Chapter shall present all charter members not dimited, with a copy of the constitution at the time of their initiation.

Art. IV. Meetings.

Sec. 1. The regular business meeting of a chapter shall be held semi-monthly, at such time and place as may be specified in the by-laws. Vacation period shall also be designated in the by-laws of every chapter.

Moved and seconded Art. IV, Sec. 1, be adopted as read.

Moved by Mrs. Townsend and seconded to amend Section by substituting the phrase "at least twice each month" instead of "semi-monthly." Amendment carried.

Moved by Mrs. Stuff, Nebraska, to amend amendment by striking out the word "Business" from the section. Amendment lost.

Motion as amended, carried,

Sec. 2. Special meetings may be called by the President but no business shall be transacted except that specified in the call.

Moved and seconded Art. IV, Sec. 2, be adopted as read. Motion carried.

Sec. 3. When a special meeting is called for the purpose of inspection, it shall be the duty of the chapter to hold a meeting for the purpose of exemplifying the ritual, except election and installation of officers. At this time or previous to the meeting, the officers must present the books of their office and the by-laws of the chapter to the organizer for examination and correction.

Moved and seconded Art. IV, Sec. 3, be adopted as read. Motion carried.

Sec. 4. If a chapter does not meet for one year, it shall be the duty of the President of the Supreme or State Chapter to ask for the surrender of its charter.

The nominee receiving the majority of votes upon the elective ballot being declared elected; but if one candidate receives two-thirds vote on the nominating ballot, the nominating ballot may be considered the elective ballot and the nominee declared elected.

Moved and seconded Art. VII, Sec. 1, be adopted as read. Motion carried.

Sec. 2. The election and installation of officers and election of delegates of chapters within its jurisdiction, shall take place annually in March.

Moved and seconded Art. VII, Sec. 2, be adopted as read. Motion carried.

Sec. 3. Vacancies in office of Local Chapters shall be filled by election, except that of President.

Moved and seconded Art. VII, Sec. 3, be adopted as read. Motion carried.

Art. VIII. Proposal and Balloting.

Sec. 1. Any person recommended for membership in the Sisterhood must acknowledge her belief in God.

Moved and seconded Art. VIII, Sec. 2, be adopted as read.

Moved by Mrs. Tieken, Illinois, and seconded to amend the section by adding "she must at least have a high school education."

Moved by Mrs. Henely, Iowa, and seconded to amend the amendment by adding the words to the proposed amendment "or equivalent" Amendment to the amendment lost.

Moved by Mrs. Bradley, Missouri, and seconded to amend the section by adding the phrase, "we recommend an initiate have the equivalent of a high school education."

Amendment lost.

Original motion carried.

Sec. 3. The form to be used in proposing a name is the adopted proposal blank of the Sisterhood. (See Supreme by-laws for adopted form.)

Moved and seconded Art. VIII, Sec. 3, be adopted as read. Motion carried.

Sec. 4. No member (except charter) shall propose a name until she has been a member of the P. E. O. Sisterhood, for one year.

Moved and seconded Art. VIII, Sec. 4, be adopted as read. Motion carried.

Sec. 5. All names shall be proposed at a regular meeting at least two weeks before balloting.

Moved and seconded Art. VIII, Sec. 5, be adopted as read. Motion carried.

Sec. 6. Balloting on a name shall be at a regular chapter meeting. The vote shall be a ball and cube ballot, with white ball to elect, black cube to reject. One black cube is sufficient to debar a canidate from admission. If only one black cube appears on the first ballot another ballot shall be taken immediately. If one black cube appears on the second ballot the candidate is rejected.

Moved and seconded Art. VIII, Sec. 6, be adopted as read.

Moved by Mrs. Townsend and seconded that we change wording of the last two sentences to read as in the old constitution which "if only one black cube appears another ballot shall immediately be taken."

Amendment carried,

Moved by Mrs. Abrams and seconded that we change the word "one" to "two black cubes to debar, etc." Amendment lost.

Motion as amended carried.

Sec. 7. The name of one who has been rejected may be proposed again after the expiration of six months after the rejection.

Moved and seconded Art. VIII, Sec. 7, be adopted as read. Motion carried.

Sec. 8. No chapter may ballot on the name or initiate a resident of another town where one or more chapters exists, without the consent of all resident members entitled to vote in each chapter.

Moved and seconded Art. VIII, Sec. 8, be adopted as read. Motion carried.

Sec. 9. A chapter may initiate women of other places where no chapter exists if they have resided in the town for one year and are well and favorably known by at least five active members who shall vouch for them over their signatures.

Moved and seconded Art. VIII, Sec. 9, be adopted as read. Motion carried.

Sec. 10. The invitation sent to persons elected to membership shall be the form adopted by the Sisterhood.

Moved and seconded Art VIII, Sec 10, be adopted as read. Motion carried.

Sec. 11. All candidates must be initiated by the officers of the Local Chapter by which they are invited. The initiation ceremony shall be conferred upon but one candidate at a time. The initiation fee of five dollars shall accompany the acceptance of the invitation.

In case of charter members of a chapter twelve or more in number, when not already, P. E. O.s all may assume the vows at the same time, being initiated by the organizer or her proxy.

Moved and seconded Art. VIII, Sec. 11, be adopted as read. Motion carried.

Sec. 12. Every person elected to membership in the P. E. O. Sisterhood should be given the opportunity to read the constitution before her initiation.

Moved and seconded Art. VIII, Sec. 12, be adopted as read. Motion carried.

Art. IX. Finance.

Sec. 1. The initiation fee of this Sisterhood shall be five dollars. This sum shall be sent with the acceptance of an invitation to membership.

Moved and seconded Art. IX, Sec. 1, be adopted to read. Motion carried.

Sec. 2. All dues shall be payable in advance.

Moved and seconded Art. IX, Sec. 2, be adopted to read. Motion carried.

Sec. 3. The annual dues of the Supreme Chapter or of members subordinate to it, are one dollar per capita payable in February.

Moved and seconded Art. IX, Sec. 3, be adopted to read. Motion carried.

Sec. 4. Each chapter shall determine the amount of its local dues and date of payment. The local dues shall be sufficient to defray current expenses.

Moved and seconded Art. IX, Sec. 4, be adopted to read. Motion carried.

Sec. 5. Assessments to meet emergencies, may be made by a two-thirds vote of the active members present. There shall be a time fixed for the payment of all assessments at the expiration of this time any member having filled to pay such assessments, is in arrears.

Moved and seconded Art. IX, Sec. 5, be adopted to read. Motion carried.

Sec. 6. The annual dues of members of chapters subordinate to a state chapter shall be fixed by each state chapter, payable in February.

Moved and seconded Art. IX, Sec. 6, be adopted to read. Motion carried.

Sec. 7. All state chapter dues shall be sent to the Treasurer of the State Chapter on or before the tenth of March.

Moved and seconded Art. IX, Sec. 7, be adopted to read. Motion carried.

Sec. 8. The Supreme and State Chapter dues of a new chapter begin in March following the formation of a chapter.

Moved and seconded Art. IX, Sec. 8, be adopted to read. Motion carried.

Sec. 9. Non-resident members are exempt from the local dues and local assessments but are termed inactive upon failure to pay the dues and assessments of the Supreme or State Chapter before March 1st.

Moved and seconded Art. IX, Sec. 9, be adopted as read.

Moved by Mrs. Bradley, Missouri, and seconded to amend by striking out word "are" and inserting the words "may be" exempt, etc. Amendment carried.

Section as amended carried.

Sec. 10. A resident member shall be termed inactive upon failure to pay dues of the Supreme, State or Local Chapter before March 1st.

Moved and seconded Art. IX, Sec. 10, be adopted to read. Motion carried.

Sec. 11. An inactive member shall deposit with her chapter the emblem which was loaned to her by the chapter initiating her, or if lost, the price of same, which emblem shall be held by the President of her chapter for three years; if she reinstates during that time her emblem shall be reloaned to her but if she does not reinstate during this period the emblem shall be returned to the Supply Department and its intrinsic value paid by said Department to the treasurer of the chapter. If the member reinstates after three years she shall pay the price of the emblem and a new one shall be loaned to her.

When a member becomes inactive she forfeits all privileges of the Sisterhood.

A member of a disbanded chapter who becomes inactive shall deposit her emblem with the State or Supreme President.

Moved and seconded Art. IX, Sec. 11, be adopted to read. Motion carried.

Sec. 12. An inactive member desiring to be reinstated must file with her chapter a written request for reinstatement, accompanying same with the sum of two dollars, one dollar of which must be sent to the State Chapter or of Supreme Chapter if subordinate to it. Upon receipt of such request the member becomes reinstated.

Moved and seconded Art. IX, Sec. 12, be adopted to read. Motion carried.

Sec. 13. Members of disbanded chapters desiring to be reinstated must file with the Treasurer of the State or Supreme Chapter, a written request for reinstatement, accompanying same with the sum of two dollars. The Treasurer shall then notify the Corresponding Secretary in whose jurisdiction they are, of such reinstatement.

Moved and seconded Art. IX, Sec. 13, be adopted to read. Motion carried.

Sec. 14. An expelled member dusiring to reinstate must file with the chapter from which she was expelled a written request for reinstatement including a statement of her desire and intentions toward the Sisterhood. The President shall then notify every active member of the chapter, of this petition for reinstatement and shall specify a regular meeting within a month for discussion of said petition after which the President shall secure the unanimous written consent of a chapter for her reinstatement. When the unanimous consent has been secured, the petition shall be ratified by a vote of the chapter at a regular meeting and the member is reinstated. The Corresponding Secretary shall forward notice of such action to the Supreme and State Presidents.

If the expelled member belonged to a chapter which had disbanded she shall file her request for reinstatement with the President of Supreme or State Chapter and the Executive Board shall have power to act, said action to be ratified at the following convention.

Moved and seconded Art. IX, Sec. 14, be adopted to read. Motion carried.

Sec. 15. An expelled member when reinstated pays to the Treasurer of her chapter the regular initiation fee of five dollars and renews her vows to the Sisterhood and is loaned an emblem.

Moved and seconded Art. IX, Sec. 15, be adopted to read. Motion carried.

Art. X. The Emblem.

Sec. 1. The emblem of the Sisterhood is a five pointed gold star with P. E. O. in black enamel in the center. This star shall be purchased by the Local Chapter through the Supply Department. All stars so purchased are loaned to the individuals for whom they were purchased but remain theproperty of the chapter purchasing them. If a chapter has been disbanded, title tosuch pins shall pass directly to the State or Supreme Chapter. Each emblem shall beengraved upon the back with the name of the member who is to wear it, the letter of her chapter, state, and the year of her initia-This emblem is for her sole and separate use so long as she is an active member of the Sisterhood, if lost she shall replace it. by paying the price of a new emblem to her local Treasurer who shall purchase a new one for her use. After the new emblem has been purchased, should the lost one be found she shall return one to her chapter and receive its intrineic value. All superfluous pins shall be disposed of by the Sisterhood. Any member loaning her emblem to one not a P. E. O. shall forfeit same and it shall be returned to her chapter.

Moved and seconded Art. X, Sec. 1, be adopted to read. Motion carried.

Sec. 2. The President shall immediately secure the emblem from an inactive or expelled member and return same to the chapter. At death the emblem shall be buried with the deceased sister or the President shall secure it and return it to the chapter.

Moved and seconded Art. X, Sec. 2, be adopted as read. Motion carried.

Art. XI. Dimit.

Sec. 1. An active P. E. O. having changed her place of residence and wishing to apply to her chapter for a dimit to another chapter she wishes to join, shall send written request for dimit. When the written request has been read in regular meeting of the chapter it must lie over until the next regular meeting, when it may be granted her by a majority vote of active members present. The Corresponding Secretary shall then fill out a dimit blank, secure the signature of the President and Recording Secretary and send it immediately to the Corresponding Secretary of the chapter to which the dimit has been issued. She shall also notify the sister of this action. A dimit is accepted by a chapter if a majority of the active members present vote in favor of it. If rejected the Corresponding Secretary must return the dimit to the chapter issuing it with notice to the chapter and to the member of the action taken. The by-laws of a chapter may state the method of extending an invitation to a P. E. O. to join them by dimit, but in no case shall limited membership prevent such invitation being extended.

A chapter refusing to grant or accept a dimit must immediately notify the Supreme

or State President of such action.

An active member may be granted a dimit to become a charter member of a chapter. The corresponding secretary shall send the dimit to the organizer of the State where the chapter is to be formed, or the Supreme Organizer, if in subordinate territory. Such dimits must be in the hands of the organizer before the petition is sent to the Supreme or State President.

Moved and seconded Art. XI, Sec. 1, be

adopted as read. Motion carried.

Sec. 2. An active member shall be entitled to a dimit if she is in no way indebted to local, State or Supreme chapter, provided written request shall have been read at a meeting at least two weeks previously.

Moved and seconded Art. XI, Sec. 2, be

adopted as read. Motion carried.

Sec. 3. A member does not leave the jurisdiction of a chapter from which she dimits until her dimit has been accepted by another chapter.

Moved and seconded Art. XI, Sec. 3, be

adopted as read. Motion carried.

Sec. 4. When an inactive member has been reinstated according to Art. IX, Sec. 12, she may apply for and receive a dimit as prescribed in Art. XI, Sec. 1.

Moved and seconded Art. XI, Sec. 4, be

adopted as read. Motion carried.

Sec. 5. No member shall be granted a dimit for other purpose than to become a member of another chapter.

Moved and seconded Art. XI, Sec. 5, be

adopted as read. Motion carried.

Sec. 6. If a dimit is not accepted before March 1st following the date it was issued, it shall become null and void and shall be returned to the chapter granting it, who shall issue another at once, without further action by the chapter.

Moved and seconded Art. XI, Sec. 6, be

adopted as read. Motion carried.

Sec. 7. The form of dimit shall be the one accepted by the Sisterhood. (See by-laws for adopted form.)

Moved and seconded Art. XI, Sec. 7, be

adopted as read. Motion carried.

Sec. 8. The members of a disbanded chapter, if active, may receive dimits to enter another chapter or to become charter members of a chapter to be formed. Such request should be sent to the state president or to the Supreme president, if in subordinate territory. The executive board to which they are amenable has power to grant such dimit or the convention, if it is in session.

Moved and seconded Art. XI, Sec. 8, be

adopted as read. Motion carried ..

Art. XII. Discipline:

To become a member of the P. E. O. Sisterhood each person must acknowledge her belief in God and her personal responsibility to Him. The Sisterhood is founded upon the principles of faith, love, purity, justice and truth, and these principles inspire and dominate each sister and become P. E. O. ideals. To uphold these ideals is the purpose of P. E. O. discipline.

Sec. 1. Any member of the P. E. O. Sister-hood proven guilty of conduct which lowers the standards of the principles of the Sister-hood may be deprived of the right to wear her P. E. O. emblem, be reprimanded, sus-

pended or expelled.

Moved and seconded Art. XIII, Sec. 1, be

adopted as read. Motion carried,

Sec. 2. Any member of the P. E. O. Sisterhood having knowledge that any sister has violated the principles of our Sisterhood shall file with the president of the chapter of such member a written statement of the facts, which statement shall be signed by her. At the next regular meeting the chapter shall appoint a committee consisting of the president as chairman and two others, who shall investigate the charges and if warranted, confer with the accused. committee shall have power to exonerate, censure, or reprimand as the case requires, and if the case warrants further action the president of the chapter shall secure the P. E. O. emblem from the accused, and notify her of the time when she may appear before the committee to refute the charges. committee shall then sit as a jury and vote to exonerate, suspend or expel and shall report their action to the chapter, which action, if ratified by a two-thirds vote of the chapter, exonerates, suspends or expels the member.

The accused has the right of appeal within ten days after sentence has been passed to the state executive board and supreme executive board whose decision shall be final.

Any member, having been accused, forfeits all rights to the Sisterhood until exonerated.

Upon suspension of a member, the president, as chairman of the committee on investigation, shall fix the time of suspension, which time shall not exceed one year, nor less than six months. At the expiration of this suspension, the member is restored to active membership and is given her emblem.

Moved and seconded Art. XII, Sec. 2, be

adopted as read.

Moved by Mrs. Spencer, Nebraska, and seconded this section be amended by striking out third clause of the section. Amendment carried. Section as amended carried.

Art. XIII. Procedure:

All meetings shall be governed by Roberts' rules of order.

Moved and seconded Art. XIII be adopted as read. Motion carried.

Art. XIV. Amendments:

Any amendment, if ratified by two-thirds of the local chapters of the state, and submitted to and adopted by three-fourths vote of the same state chapter convention, shall be immediately reported by the recording secretary of said state chapter to the recording secretary of the Supreme Chapter, and if approved by a three-fourths vote of the Supreme convention, it shall become a part of the constitution governing local chapters in state and subordinate territory, but if the same be not approved by a three-fourths vote in the Supreme convention, such amendment shall be of no effect.

Moved and seconded Art. XIV be adopted

as read. Motion carried.

Moved by Mrs. Baird, Nebraska, and seconded we give the committee on revisions a rising vote of thanks for the faithful performance of their duty on this committee.

Motion unanimously carried.

Report of committee to examine proposed by-laws and rules of administration.

We, your committee, appointed for the purpose of examining proposed by-laws and rules of administration, have examined the changes proposed by the revision committee.

It would be the wish of your committee, and the expressed wish of the revision committee, that these proposed changes in bylaws and rules might come in detail before this convention for consideration. But in view of the fact that the important work of revising our constitution has necessarily occupied almost the entire time of the convention, the committee feel that the short time allotted could not be sufficient for the due consideration of these important points.

We have gone carefully over these proposed changes and have found that no changes have been proposed except those made necessary by the revision of our constitution. We further find that these changes and rules, if adopted, would conform in every particular to changes already made in our constitution. We feel that the proposed rule of administration are especially

concise and practicable.

Inasmuch as the revision committee in its two years of thorough study, has given these matters more time and thought than this committee could possibly do in the short time at its disposal, we, your committee, recommend the adoption of these changes and the rules of administration with this provision: That all necessary minor changes be left to the discretion of the revison committee, providing always that these do not in any way conflict in intent or purpose with those already made.
